

INSTRUCTIONS FOR USE – PROFESSIONAL EYELASH GLUE

SMART LASHES – F1 GLUE – UFI PXR2-F0ER-S00P-YWWX

This product is intended exclusively for professional use in eyelash extensions. Please read the following instructions carefully before use.

Type: Cyanoacrylate Adhesive

1. Field of application:

Professional application of false eyelashes using the eyelash to eyelash method. Not suitable for standalone home use.

2. Method of application:

- Shake well before use (approx. 10-20 seconds).
- Apply a small amount of glue to the false eyelash.
- Attach the lash 1-2 mm from the roots of the natural lash.
- Make sure that the adhesive does not come into contact with the skin or mucous membranes.
- The customer must keep her eyes closed throughout the application until the adhesive is completely dry.

3. Recommended conditions for work:

- Temperature: 20–25 °C
- Humidity: 50-60%
- Use a humidifier or dehumidifier as needed.

4. Safety Warnings:

- The adhesive contains cyanoacrylate.
- May cause irritation to the eyes, skin and respiratory tract.
- Avoid inhaling fumes.
- Wear a protective mask and a well-ventilated area.
- In case of skin contact, wash immediately with soap and water.
- In case of contact with eyes, rinse immediately with water and consult a doctor.

5. Storage:

- Store well closed in a dry and cool place (ideally 5-25 °C).
- Once opened, consume within 1.5 months.
- Protect from direct sunlight and moisture.
- Keep out of reach of children.

6. Important information:

- The product is intended for professionals only.
- We are not responsible for damage caused by improper use.
- We recommend performing a sensitivity test before using it for the first time.

Danger

- **H315** – Irritating to skin.

- **P305+P351+P338** – If in eyes: Rinse cautiously with water for several minutes. Remove contact lenses, if they are fitted, and can be easily removed. Continue rinsing.
- **P332+P313** – If skin irritation occurs: Get medical advice/attention.
- **P333+P313** – If skin irritation or rash occurs: Get medical advice/attention.
- **P337+P313** – If eye irritation persists: Get medical advice/attention.
